I/We understand that the withdrawals hereby authorised will be processed by computer through a system provided by the South African Banks (Standard Bank), and I also understand that details of each withdrawal will be printed on my bank statement or on an accompanying voucher.

I/We agree to pay any bank charged relating to this debit order instruction.

I/We will be charged R50 per failed transaction. It is acknowledged that MrMail will only do one debit transaction per month, if money fails to get drawn from my/our account, I/we will be responsible to transfer funds into the MrMail bank account alternately resulting in suspension of my account by the 10th of each month.

This authority may be cancelled by me/us by giving you one calendar month notice in writing, sent to or by prepaid registered post to PO Box 1128, Westville, Durban, 3630. I/We understand that I/we shall not be entitled to any refund of amounts which have withdrawn while this authority was in force if such amounts were legally owing to you.
